a) WD/2019/1096/F Land adjoining The Oaks, Tunbridge Wells Road, Rotherfield, Argos Hill, TN6 3QH

Erection of a two storey detached dwelling.

Two residents who live adjacent joined the meeting and the Chair permitted them to present their concerns regarding the proposal for the site.

**REASON**. The proposal is an overdevelopment of the site.

**REASON.** There are already several signs in the area and a further one will make little difference.

After advice from Cllr. Kitchenham Clerk has recommended to the applicant, Mark Cross School, that they liaise with the Diocese as a Faculty may be required to erect the sign on Church land.

**d) WD/2019/1166/F** The School House, 15 The Forstal, Eridge, TN3 9JX Front extension for provision of a ground floor w.c facility.

It was **RESOLVED** to recommend to Wealden District Council that this application be **APPROVED.** 

**REASON**. It will enhance the facilities of the property.

**e) WD/2019/1207/FR** Oakwell Cottage, Sheriffs Lane, Rotherfield, TN6 3JE Retrospective application for single-storey extension.
