The Council have been contacted by a Parishioner raising concerns that the shared driveway to his property was being damaged due to heavy use for access to another property served by it. He considered that there was a condition in the planning consent that set restrictions on traffic movements. As the Parish Council has no powers in this respect it was recommended that they contact the Wealden District Council Planning team regarding the matter and to clarify any conditions imposed by the original consent.

Cllr. Dixon has sent a report regarding the current position regarding a caravan on a property in the Parish which was considered as being used for residential purposes. Wealden District Council Enforcement Officers have concluded that the caravan is not being used for residential purposes and, as it is only being used for purposes ancillary to the current planning use for the land, does not require planning permission. No further enforcement action is being taken.

- Cllr. Kitchenham commented on the much improved tidy appearance of the verges in Station Road. These have recently received attention from our grass cutting contractor.
- Cllr. Hiles noted that there was some subsidence on the B2101 approximately 100m from the Bicycle Arms junction if approaching from Rotherfield. CLERK to raise report with East Sussex Highways.
- Cllr. Kember raised concerns regarding the recent decision of the Planning Inspector that the submitted Wealden Local Plan cannot be taken forward to adoption. Council Chair has asked for an item to be added to the agenda of the January Council meeting to consider this, also that a Freedom of Information Request be submitted to Wealden for details of the cost of the work undertaken on the Plan to date. - Cllr. Kember enquired when the suggestions made by a Parishioner at the 17th September
 meeting of the Council's Highways Committee in respect of the North Street and High Street
 junction would be investigated by East Sussex Highways. Clerk advised that this will be
 raised at the forthcoming Strengthening Local Relationships meeting with Highways Officers.
 They will be asked to view the site, also the area of Rotherfield Hill for which an adjoining
 footpath has been suggested on Highways owned land near Palesgate Lane.
- Cllr. Wickenden raised concerns regarding the placing of the "Town Row" sign in Station Road.
 Clerk advised that East Sussex Highways had confirmed that the contractors had installed it
 in the wrong location, CLERK to add item to the agenda of the forthcoming Highways
 Committee meeting to agree correct location, and to contact Highways for an update
 regarding the issue with the placing of a similar sign on Catt's Hill.
- CLERK to investigate obscured direction sign at the foot of Spout Hill approaching the B2100 junction.
- Concerns raised that waste bins were obstructing the Church Path right of way 22c/22d near the Surgery. It is considered that these were a hazard, particularly at night. CLERK to investigate and report to the ESCC rights of way team.

The Chair declared the meeting closed at 20:10.
