The deadline advised by Wealden District Council for receipt of the Parish Council's signed official precept notification is Friday 15<sup>th</sup> January. It was therefore agreed that the 5<sup>th</sup> January 2021 Planning and Building Committee meeting is to be redesignated as a Full Council meeting to permit a decision to be made. **CLERK** to note.

### 3. OTHER ITEMS

To review the following: -

#### i. Cost centres and account codes.

It was agreed that committee Chairs would review and advise Clerk of any changes required

#### ii. Accounting software used by the Council.

The Clerk informed the committee that after speaking to other Clerks in the area that all are using the Rialtas software and it is considered the best for managing local authorities of all sizes. Multiple report options are available and it was agreed that the Clerk would investigate different reporting formats.

#### iii. Financial Regulations and changes suggested to section 4.1 regarding delegated spending power.

The Chair had circulated the following proposed amendment ahead of the meeting:

*"4.1. Expenditure on revenue items may be authorised up to the amounts included for that class of expenditure in the approved budget. This authority is to be determined by:*

- the council for all items over £5,000*
- a duly delegated committee of the council for items of £5000 or below; or*
- the Clerk, in conjunction with Chair (or Vice Chair) of Council or Chair (or Vice Chair) of the appropriate committee, for any items of £1000 or below. This authority is not to be used in a manner so as to bypass the Council or Committee."*

It was **RESOLVED** that this amendment be adopted. **Council Administrator** to update and publish amended Financial Regulations.

### 4. Urgent issues for noting or inclusion on future agenda.

- Cllr Richardson raised the possibility of including a local nature charity in the grants for the next financial year.
- Cllr Harris thanked Cllr Henrick & Martin for their hard work in preparing for this meeting.
- Cllr Kitchenham asked about building works at Sunnybank on Station Road Rotherfield. It was reported that enquiries had been made through Cllr Dixon (Wealden District Council) and it was confirmed that no planning permission was required for these works.
- The Clerk asked if the Council wanted to renew their subscription to Rotherfield and Mark Cross Parish News. It was **AGREED** that the subscription be renewed and that the council wished to pay £20 for the year – spending will be authorised under delegated powers.
