1. TO RECEIVE THE FOLLOWING: -

a) Public forum.

- b) Apologies for absence (LGA 1972 s85) Cllr. P. Beach submitted an apology, and it was **RESOLVED** that the reason for his absence was approved.
- Declaration of personal, prejudicial, and disclosable pecuniary interests on items on the agenda, and updates to members' register of interests. None declared. The Chair reminded the Councillors present that they should declare an interest at any point of the meeting if they became aware of one in connection with an item being discussed. Councillors who are receiving payment for work undertaken on behalf of the Council are reminded to declare a personal and pecuniary interest.
- To resolve that the Minutes of the meeting of this Committee held on 21st September 2021 be taken as read, confirmed as a correct record, and signed by the Chair. It was **RESOLVED** that these be adopted as a true record of the meeting, and they were signed by the Committee Chair.
- Budget report to date for this Committee and consider any actions required. Budget and nominal ledger reports were circulated with the summons and agenda. No actions were required.
- Report and updates regarding matters arising and actions from, previous meetings f)
 - Fingerposts repairs JAKK have been asked for a progress report on the work agreed. North Street junction see item on this agenda.

 - Reflective bollards have been installed by ESCC although some appear to have been removed.
 - Trees on ESCC land they have been chased for a response to our request for

 - Improvements to parking by the bank in North Street by the Rec. A site meeting has been arranged for this project.

- Drainage issues. Councillors involved to update please. Enquiries continue regarding drainage/debris issues arising at the New Road/Station Road junction. Cllr. Kember is to draft a letter to the residents at this location regarding the matter. The boundary of the "unadopted" section of the road is to be established.
- Strengthening Local Relationships (SLR) meeting with East Sussex Highways officers. Clerk has chased for dates available from ESCC so that a venue can be booked.
- Match funding from ESCC Item on this agenda to agree way forward with the Council's successful application.
- Eridge Station. Clerk and Sharon Gray of the SCR are trying to establish when the work
 to install the lift will be completed. Sharon has reported that new fence is being fitted
 around the corner of Groombridge Lane and suggests that this would be a good site for
 a sign to raise awareness of the car park. On road parking near the station is increasing
 but, so far, the posts have deterred parking on the Crowborough side verge.

2. TO CONSIDER INFORMATION AND MAKE DECISIONS ON ACTIONS AND EXPENDITURE AS REQUIRED REGARDING THE FOLLOWING ITEMS

a) Review and adopt committee Terms of Reference. These have been reviewed by the Deputy Clerk who recommended that it be adopted without change. It was RESOLVED that the document be adopted unchanged.

b) ESCC Urban Cut. Agree arrangements for 2022-23.

The map of the area covered by this arrangement had been made available to the Councillors prior to the meeting showing areas covered by this. It was **RESOLVED** that the Council will continue with this arrangement with the cutting undertaken by a local contractor and a financial contribution from ESCC. **CLERK** to request the documentation for completion from ESCC.

- c) Agree 2021/22 Budget and precept requirements.

 After discussion it was RESOLVED that this Committee's budget for 2022/23 be set at a figure of £57350 (£50500 for 2021/22).
- d) Information regarding cost of repair/replacement of streetlights 39 and 43 in New Road. ESCC Highways have been asked to indicate the cost of replacements. ESCC are to review the "system of lighting" in New Road to see if is appropriate and will report the outcome to the Council.
- e) North Street junction. Receive report from site meeting, and layout plan provided for suggested amendments to improve pedestrian safety, traffic flow and parking. This was dealt with as first item in this section of the agenda as the parishioner who has suggested the scheme was present and was permitted to address the meeting to share details; It is similar to the proposal of around twenty years ago. It was RESOLVED that the Council supported the project and that details be passed to the ESCC Highways Officer dealing with the matter to seek further information, particularly that of cost, which could be part covered by a "Match Funding" application.
- f) Receive outcome of the Council's application to the ESCC Community Match Scheme 2021-2022 for speed limit awareness measures in Rotherfield Village. £12500 has allocated to the Council from this scheme. Ian Tingley from Highways has been in touch to seek our requirements. The application was for provision of speed awareness measures on the B2100 approaching the Village from Crowborough; possibly enhanced highway markings and a "gateway" arrangement. It is recommended that that a site meeting is

held to see what can be provided with a total cost of £25K after "match funding" by the Parish Council. It was **RESOLVED** that a site meeting with ESCC officers be arranged with Cllrs. Kitchenham, Martin and Harris, together with the former Councillor who had first proposed measures at this location.

g) B2100 Rotherfield Hill - cost information for relocating telegraph pole.

BT Openreach has quoted £1,106.50 inclusive of VAT. This is for a study for the work required: if it is decided to proceed additional costs will be involved. It was **RESOLVED** that the Council would not proceed with the relocation but will continue to lobby ESCC Highways for measures to reduce speeds here.
