1. TO RECEIVE THE FOLLOWING: -

a) Public Forum:

Cllr Georgia Taylor (East Sussex County Council):

A report from Cllr Taylor had been circulated to Councillors ahead of the meeting.

- Cllr Taylor reported that a motion for East Sussex County Council to, 'Say No to Fracking,' was not moved since the Government decided to keep the ban.
- Cllr Taylor confirmed that East Sussex Highways was now only gritting roads in wintery conditions and not pavements. Cllr Kitchenham asked for clarification that in order for Highways to fill parish grit boxes the cost would have to be met by the Parish. This was confirmed.
- Cllr Taylor reported that East Sussex Highways is currently inundated with repair requests following the recent bad weather. It is generally acknowledged that there are worse road surface problems in the north of the county.
- Cllr Kember thanked Cllr Taylor for a most detailed report. He expressed concerns about the condition of Bunny Lane which had recently been featured in the national news for its very poor condition. Cllr Martin reminded all present that Bunny Lane was a designated HGV route as part of the lorry restrictions for the parish.
- Cllr Taylor reported that she was following up on concerns expressed about the shocking communications between South East Water and residents following the latest water outage. Clerk confirmed that he had arranged for Douglas Whitfield and Matthew Dean (Head of Operations for Sussex) & Jo Shippey (Community Engagement Manager) to attend the 31st January Planning & Building Committee meeting.

2. RECEIVE PRESENTATION FROM MRS DE LANNOY & HAVEN HOMES CROWBOROUGH ALMSHOUSE CHARITY.

Two Trustees from the charity addressed the Council about the history of the charity and what their aims are for the future development of Alms Houses in the area. The charity is looking to find land or build Alms Houses in the surrounding area of Crowborough and has identified Rotherfield as a possible area. Ideally, they would be looking for a piece of land where they could build six housing units.

The Council were asked if they believed there was a need for this type of housing within the parish. Cllr Buck believed there was a requirement for this type of housing in the parish and believed we should support the initiative. Cllrs Hiles and Kember confirmed they would be willing, through the Planning & Building Committee, to support the charity trying to find some land or an existing property that would meet the charity's aims.

Cllr Harris asked if the Charity had funds for this and it was confirmed that they had funds and access to grants to see the project through.

Cllr Kitchenham enquired how many rooms formed part of a unit. It was confirmed that usually, this existed of one bedroom, kitchen, living room and bathroom.

It was **RESOLVED** that in principle the Council supported the desire of the Charity to create some Alms Houses within the parish. It was **AGREED** that a general discussion about possible locations would be placed on the agenda of the 21st February Planning & Building Committee meeting. **Clerk** to add an item to the agenda of the 21st February Planning & Building Committee meeting.

Clerk to share contact details of charity trustees with Cllrs Hiles & Kember.
