1. INTRODUCTION OF COUNCILLORS & OFFICERS

The Councillors and Officers introduced themselves to the members of the public.

2. TO RECEIVE THE FOLLOWING: -

a) Public Forum:

A presentation was received from a representative of the Millennium Green Trustees on the current status and future of the Millennium Green.



- The Millennium Green now has nine trustees, volunteer wardens and monthly working parties all playing an active part in managing the Green.
- The charity has developed a regular maintenance plan for the Green.

- The trustees would like to approach the Parish Council with regard to taking on responsibility for managing the hedge running along the side of the St Chéron Twitten. The Clerk advised they would need to wite to the Council for this to be considered by the Council.
- The next project of the charity is to reconfigure the boardwalk to exclude cows and dogs from entering the wetland.



- The trustees are currently working on a longer term project to extend the existing pond (see above) and refence it permanently to replace the need for the electric fence to be erected each year.
- The Charity would like to prevent dogs from entering the pond as the tick and flea
 treatments on dogs can wash off and harm the pondlife. It was suggested that
 the Charity could consider erecting some signage saying dogs are not allowed in
 the pond.
- There is an increasing amount of dog poo being left on the Green and not put in the bins, this could be because the bins are very full but attempts to negotiate more frequent collections or larger bins with Wealden District Council have been unsuccessful.
- Finances have dropped over recent years and the number of Friends of the Millennium Green have dropped. The Charity is going to have a recruitment drive this year to try and increase the number of friends.
- Councillors asked if the permissive access that the Green has over parts of the land had any conditions attached. The Trustee confirmed that the permissive access can be withdrawn at any time. As a result long term projects in these areas are not being considered by the Chairty at this time.
- Cllr Harris thanked the Trustee for the presentation and urged the Trustees to approach the Council for any support they may require.
