3. RECEIVE REPORT FROM THE 11TH NOVEMBER COUNCILLORS' SURGERY, CONSIDER RESIDENTS' VIEWS REGARDING THE GOVERNMENT'S PLANS TO HOUSE ASYLUM SEEKERS IN CROWBOROUGH ARMY CAMP AND RESOLVE FURTHER ACTIONS.

Documents relating to this item had been circulated to Councillors ahead of the meeting.

Six members of the public addressed the Council and raised the following points:

- No quality impact assessment had been carried out on the condition and proposed use of the site.
- Members of the public with personal experience of the site are concerned that the site contains a large amount of asbestos.

- Those housed at the site will be free to come and go from the site. Research shows that at least 10% do not return to the camp.
- The effect the plans will have on the local doctors' practices. Particularly with the Rotherfield Parish practices being required to register at least 50 asylum seekers each. Concerns that appointments will take double or triple the time of a standard appointment. Despite the Home Office assurances, the plans will have a noticeable impact on the local health services.
- The loss of the camp for use by the local cadet forces.
- Security of residents in Crowborough and the surrounding towns and villages. A lack of funding and resources for an already overstretched police force.
- The number of 540 asylum seekers at the camp is misleading, as it is a rolling program.
- Concerns for the safety of schools and those travelling to and from school.
- Concerns that, given the amount of money being spent on the site, the camp will last longer than the twelve months proposed.
- The government's proposals will change the nature of Crowborough and the surrounding towns and villages.
- Concerns that the government can act in this way when planning applications are refused on the grounds of the Ashdown Forest 7km zone of influence. It is understood that this Special Protection Area applies to Crown Land.
- Any representation the Parish Council makes should also consider the health and well-being of the asylum seekers. The Council should recall that the local areas have already welcomed the families of Afghan interpreters and Ukrainian families.

The Chair asked Councillors for their views:

Cllr J Gosney felt that there was total confusion regarding this situation and that the government had made up its mind and nothing we could do as a Parish Council could change that.

Cllr P Beach agreed with Cllr Gosney that the situation seemed like it had already been decided. He added that residents have very valid security concerns. The public has expressed these to the Parish Council, and we should, as a minimum, communicate these to the Home Officer and other stakeholders. Everyone deserves a place to live, but the infrastructure at the camp in the surrounding areas is not in place to support the government's plans.

Cllr D Johnstone reported that he had been on the first protest march and heard very valid concerns from residents, including some from the parish. One of the residents' key concerns was that the irregular migrants could come and go from the camp as they pleased.

Cllr J Richardson felt that we faced a fait accompli. The mental health of the many youngsters from Crowborough and the surrounding areas who use the army camp through the cadet forces will be a cause for concern. The well-being of young people must be something the Council has a duty to lobby for.

Cllr D Hiles added that any site containing 600 people would create tension. He added that he would not be able to support a Council statement that dehumanises asylum seekers.

Cllr B Johnstone said that she felt that the Council needed to decide whether or not to oppose the government's current proposal for the Camp. She recognised that reducing the issue to a binary choice posed some difficulties as it is important not to lose sight of the humanity of the irregular migrants but at the same time this plan will have a direct effect on the parish's residents and there are many valid concerns, which the Council should reflect by opposing the government's plan. The Standing Orders of this Council state that the Council may consider any Motion that specifically affects the Council's area or its residents, and therefore she felt the Council should clearly should represent their views and oppose this particular policy.

Cllr P Turner felt that it was not for this Council to oppose or approve of the government's plans. He would support a letter or statement expressing residents' views.

Cllr P Kember agreed that this Council should not vote on a motion to refuse or oppose the government's plans. However, he would support a letter passing on residents' concerns. If a motion to oppose or approve was called, he would abstain.

Cllr D Johnstone replied by saying Parish Councillors are elected to represent the residents, and the residents are clearly opposed to this.

The Chair addressed the Council, saying that he believed this would have an adverse effect on our local health services, particularly GP services. There are no plans for additional policing or to address residents' security concerns. The Parish Council does have an overriding duty to be the community voice and to represent its residents, and residents who had contacted him were scared for their own or their families' well-being. In addition to making the Home Office aware of our residents' concerns, he would be happy to have a motion to oppose these plans. However, he would accept a vote on a mechanism to inform the Home Office of residents' concerns and express our severe disappointment at the lack of consultation with surrounding towns and parishes.

It was **RESOLVED** that the Clerk write to the Minister of State, Alex Norris (MP), and other stakeholders expressing the concerns of the residents of the Parish of Rotherfield regarding the government's plans to house 540 asylum seekers in Crowborough Arm Camp.

The key points will be taken from the views expressed at the public meeting on Tuesday, 11th November, this Extraordinary Parish Council meeting and correspondence received. They will cover the following:

- Health Service Impacts
- Additional Policing
- Security and Mental Health of Residents
