3. TO CONSIDER AND MAKE RECOMMENDATIONS ON THE FOLLOWING PLANNING APPLICATIONS ON BEHALF OF THE PLANNING & ENVIRONMENT COMMITTEE.

a) WD/2025/2739/F - Bullfinches Farm, Forge Road, Eridge, TN3 9LJ

Conversion of existing building in lapsed combined b1 & b8 use (now defaulted to agricultural) to a residential dwelling c3 use, including changing the roof covering to original plain tiles, cladding the walls with timber weatherboarding and the erection of raised decking. Erection of an agricultural style double garage adjacent. **Amended description.**

It was **RESOLVED** to repeat our recommendation to Wealden District Council that this application be **APPROVED**. The committee had no further comments on the application.

b) WD/2026/0256/FA - Rother House, Station Road, Town Row, Rotherfield, TN6 3HU

Variation of condition 1 of WD/2025/1651/F (demolition of conservatory. Erection single storey rear extension) change of roof from pitched to flat roof with parapet and lantern roof light.

It was **RESOLVED** to recommend to Wealden District Council that this application be **APPROVED**. The committee had no further comments on the application.

Cllr J Richardson requested holding some competitions to be judged at the Parish Assembly. It was **RESOLVED** to have three categories of competition for different age groups all with a theme of Rotherfield Parish.

It was **AGREED** that free bacon sandwiches and tea and coffee would be offered. The Parish Council would make an equivalent donation to the church in return for this. The cake stall would remain as before.

It was **RESOLVED** that the event would be named, 'The Parish Get Together – the Annual Parish Meeting'. In the advertising there would be a distinction between font size for the first and second part of the title. **Clerk** to arrange advertising and ensure name is changed accordingly.

iii. Discuss use of funds received from the Rotherfield Twinning Association.

Documents relating to this item had been circulated to Councillors ahead of the meeting.

It was **RESOLVED** to reply to the former Twinning Association that they are happy with the introduction of a planter to commemorate the Twinning but would like the location to be on the grass triangle next to Rotherfield Primary School.

It was **RESOLVED** to fund a plaque as suggested by the former Twinning Association with one slight amendment to the wording.

Clerk to contact the former Twinning Association members and feedback on our decisions.

It was proposed that an event be arranged to mark the installation of this planter and the twinning link with an invite for representatives from St Chéron to attend. **Clerk** to discuss this with former Twinning Association members.

It was **AGREED** by the committee that Cllr Paul Snelling would draft the text for the Spring newsletter and will be reviewed by the Clerk and Chair of the Committee. **Clerk** will notify Cllr P Snelling of the deadline.
