- Cllr Michael Lunn reported that he had been in touch with East Sussex Highways regarding the road closure of Church Road, Rotherfield. Temporary repairs have been completed
- Cllr Michael Lunn reported that the structural works on the bridge over the river at the bottom of Station Road are still in the design stage, and they are not expecting the application until late autumn. Stakeholder Liaison will keep us updated.
- Cllr Michael Lunn confirmed that some of the relining on Station Road and South Street had been completed, but more remains to be done. These have been raised at a recent site meeting with East Sussex Highways.
- Cllr Michael Lunn reported that a forthcoming road closure of the A267 was due to start on the 3rd August 2026, and that traffic management will be in place using two-way traffic lights.
- Cllr Michael Lunn reported that his induction training is now complete and he has been appointed to the Ashdown Conservators and the High Weald National Landscape Group.
- Cllr Paul Turner asked if it would be possible for East Sussex Highways to investigate the possibility of having a keep clear box painted on the road surface at the top of New Road. **Cllr Michael Lunn** to raise with East Sussex Highways and report back.

Cllr Georgia Taylor (East Sussex County Council)

- Cllr Georgia Taylor reported that she attended the A26 Consultation meeting along with Cllr Jessika Hulbert and the Clerk. A full report and further consultation will be presented to councillors in the future.
- Cllr Georgia Taylor reported that she had received a briefing on Local Government reorganisation and that we were still on track for a Mayoral Authority in 2028. However, with a change of government leadership coming up, plans may change; therefore, the timeline is still unclear.

Cllr Jessika Hulbert (Wealden District Council)

- Cllr Jessika Hulbert confirmed that she had nothing further to raise.

Cllr Michael Lunn (Wealden District Council)

- Cllr Michael Lunn reported that the partners who had agreed to match fund the 100-anniversary celebration of the Ashdown Forrest and Winnie the Pooh had pulled out. It is not clear, yet what future funding measures are in place to cover the loss of the match funding.
- Cllr Beverley Johnstone asked if there was any news on the Cycle Track to Lewes. Cllr Lunn replied that it is waiting on a decision but it is now up against the BML2 for which the government is conducting an ongoing feasibility study.
- Cllr Michel Lunn confirmed that official notification had now been given that the Crowborough Army Camp would be open to 2030 and most likely expanded to accommodate more asylum seekers. He reported that he had recently visited the site as part of a tour for District Councillors.
- Cllr Michael Lunn reported that there were no updates on the Highfields Farm planning application.

Retrospective planning application for an agricultural bund constructed to facilitate a water collection area to support the planting of an additional orchard to link two existing orchards. **Amended proposal description, plans and supporting information**

It was **RESOLVED** to recommend to Wealden District Council that this application be **REFUSED**. The Council gave the following reasons:

- 1) The impact on the High Weald National Landscape is significant with a clear interruption in the landscape.
- 2) The Council felt that the applicant had failed to adequately demonstrate the agricultural need for the bund.
- 3) The Council felt that the visual and cumulative impacts are not accessible in planning terms.

One member of the Council abstained from voting on this application.
